Presidential \$1 Coin - Lady Liberty




The United States is honoring our Nation's Presidents by issuing \$1 circulating coins featuring their images. The U.S. Mint, starting February 2007, will issue four Presidential coins per year in chronological order by their term in office. Each Presidential coin will be issued for 3 months before going on to the next President. The program begins with Washington, Adams, Jefferson, and Madison in 2007.

The obverse (front) of the coin will have the President's image, name, and when served as president. The reverse (back) of the coin will feature a striking version of the statue of Liberty, the inscription "\$1," and the inscription "United States of America." In addition, inscribed along the edge of the coin will be the year of minting or issuance of the coin, "E Pluribus Unum," "In God we Trust," and the mintmark.
